And

Zila Parishad, Chattogram is a Local Government Institution, having its office at Court road, Chittagong by its Chief Executive Officer, Md Didarul Alam or Nominated Authorized Representative, (which expression shall, unless excluded by or repugnant to the context or meaning thereof, mean and include its successors-in-interest, legal representatives, administrators, executors, and assignees) of the SECOND PARTY.

- a. Whereas IBN SINA TRUST (1st party) is the pioneer organization in health care sector in Bangladesh and committed to render world-class services with reasonable cost.
- b. And Whereas Zila Parishad, Chattogram (2nd party) is desirous to take medical services for their Employees and their legal dependents from all unit of IBN SINA TRUST under the following terms & conditions:

- 1. The IBN SINA TRUST agrees to provide the following discounts on medical services to the Employees and their legal dependents of Zila Parishad, Chattogram.
 - a. 35% discount on all kinds of Pathological Tests
 - b. 30% discount on all kinds of Radiological and Imaging Tests
- 2. The discount provided by the IBN SINA TRUST shall exclusively apply to the Employees of Zila Parishad, Chattogram and their legal dependents. Legal dependents are parents, spouse and children. Any other facilities, if includes/increases in future by the IBN SINA TRUST authority, which will be applicable under this agreement and will be informed to Zila Parishad, Chattogram.

3. Identification:

- 3.1. Employee will show ID card, Visiting Card or any written documents with authorized signature.
- 3.2. Dependents will show the photocopy of respective Employees ID card.
- 4. All payments of the medical services shall be made in cash/debit/bkash/nagad or credit card by the Employees of Zila Parishad, Chattogram and IBN SINA TRUST shall provide the respective invoices for such medical services provided to the Employees of 2nd parties.
- 5. **IBN SINA TRUST** and (including their officers, Employees and independent contractors) shall treat all information received from each other as confidential and undertakes not to disclose any confidential information to any third party. This clause shall be enforceable even after the termination of this agreement.
- 6. This MOU shall be governed in accordance with the relevant laws of the People's Republic of Bangladesh for the time being in force. If any difference arises as to resolution of any matter under this agreement, such difference shall be settled through mutual discussion between both the parties. However, the parties do consent and submit to the exclusive jurisdiction and venue of the Bangladesh courts for any litigation with regard to execution, performance or breach in any manner arising out of this contract if not resolved mutually.
